CREDIT COUNSELING AND FINANCIAL MANAGEMENT COURSES

- ◆ You must complete the credit counseling before we can file your case.
- ◆ You must also complete a Financial Management course and file a certificate with the court within 45 days of your 341 Hearing in order to receive a discharge.
- ◆ You will need to arrange payment directly with the credit counseling agency that you choose.
